Financial Agreement

Read carefully & sign annually.

- We understand that HCS makes no refunds on registration fees and deposits. We agree to pay tuition one of the following ways:
 1. In one annual payment due in August
 2. In 2 equal payments due in August and January
 3. In equal payments due on the first day of each calendar month beginning July or August and ending May
- We understand that progress reports, grade cards, and records are held if the account is outstanding during any grading period. If after 30 days the account is still delinquent and satisfactory arrangements have not been made with the school, the student is suspended until payment is made. No refunds are made for tuition paid if the student is withdrawn after the 5th of the month. (Exception: If tuition was paid for the year or semester, it is prorated to the month due.)
- We understand that after receiving notice of acceptance to HCS, a deposit of \$250.00 is due within 10 days in order to hold the student's placement. The deposit for current students who are re-enrolling is due by June 1st. The deposit is not refundable and must be paid along with the monthly tuition before a student may begin classes.
- We agree to be responsible for all tuition and any other financial expenses that our student incurs. All accounts are to be paid in full before a student may re-enter or register for the upcoming school year. All school records are held until any outstanding balance is paid in full.
- We understand the importance of parental involvement in training children and the fact that tuition does not cover the actual cost of HCS, therefore we support annual fundraisers & give above tuition. We agree to support the school in prayer and to participate in volunteer service opportunities, as well as, Parent/Teacher Fellowship meetings.
- We understand assessments are made to cover damages to the school, including breakage of windows and abuse of property whether intentional or accidental.

Statement of Cooperation

Read carefully & sign annually

- We have read HCS' Parent/Student Handbook and fully support the administration of them.
- We agree with the standards of conduct & discipline & grant authority to the teacher and administration to discipline our student when necessary. It is our belief that the final responsibility of physical discipline lies with the parent so we honor the school's policy. We will come to the school to administer punishment when asked and/or discipline at home as needed.

- We understand that each student is enrolled “at will”, therefore, HCS reserves the right to dismiss any student if the student or the parent does not cooperate with the educational process. We understand HCS' standards do not tolerate disrespect to the school's personnel or continued disobedience to the established policies. If our student does this, we realize suspension or expulsion may be in order. If a student is dismissed for any reason, tuition and fees are not refunded.
- We understand that HCS must be notified in advance of the withdrawal of any student. Withdrawal forms must be completed, all tuition fees paid, and all books returned before any records are released.
- We give permission for our student to participate in all school activities, including school-sponsored trips away from the school premises. We absolve the school, its administration, employees, and its sponsoring church from liability to our student or myself because of any injury to our student at school or during any school activity. In case of accident or serious illness, we request the school to contact us. If the school is unable to reach us, the school may make whatever arrangements seem necessary.
- We will faithfully support the school through prayers and a positive attitude and share any complaints, questionable or negative comments with only the people involved (administration or faculty) and not around our child or other parents.
- We agree to uphold and support the academic standards of HCS by providing a place at home for our student to study and we will encourage him in the completion of homework and assignments.
- We understand that, as a Christian school, HCS is committed to resolving conflicts in a biblical manner according to Matthew 18:15-17. If a problem arises, we agree that we will schedule a meeting with the individual involved first before going to their superior.
- We know HCS admits students of any race, color, national, and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students. HCS does not discriminate in the administration of its educational policies, scholarships, athletic, and other school programs.
- We understand that promotional advertisements are used by HCS & agree that our student/s may be used for advertisements. HCS is released from all liabilities.
- We know that HCS reserves the right to change any policy at any time when in the discretion of the board/administration, it is determined to be in the best interest of HCS.

BY SIGNING THIS AGREEMENT, WE ACKNOWLEDGE THAT WE HAVE READ, UNDERSTAND, AND AGREE WITH THE HANDBOOK, FINANCIAL AGREEMENT, and STATEMENT of COOPERATION. WE ACCEPT THE RESPONSIBILITY TO MEET ALL FINANCIAL OBLIGATIONS AND ABIDE BY THE RULES OF HCS.
